Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 6 (2 each for Bal Vatika I, II & III respectively). The total number of sections from classes I to XII shall be restricted to 22. Any further increase shall require prior permission of the Board and shall be subject to compliance with the affiliation Bye laws and availability of rooms of >500 sq ft dimensions.
2	CWSN facilities like ramp at the entrance is not seen in the videography. CWSN toilets are not seen on all the floors. Thus the school shall ensure ramp at the entrance and construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS with videography
3	Maths lab does not have proper demonstration table. Separate units of chair tables are arranged which are not appropriate for conduct of practical. Safety features like exhaust fan, emergency exit are not seen in Composite lab. Hence the school is directed to upgrade the labs as per SoP issued by the Board and submit the videographic compliance within 3 months on SARAS portal.
4	The computer lab does not have proper infrastructure (no AC). Hence the school is directed to upgrade the lab as per SoP issued by the Board and submit the videographic compliance within 3 months on SARAS portal.

The school shall conduct training of its teachers with CoE Bhubaneswar within 3
months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.

The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
