Director of Public Instruction shall ensure that the concerned school is registered and recognized by the Competent Authority of the State Government, otherwise the school will be considered as Unauthorized School and legal action will be taken as per Karnataka Education Act, 1983.
- The management shall obtain the permission from the concerned Board and submit the same to the concerned Dy. Director of Public Instruction, before commencing the CBSE syllabus school.
- The school being governed by Government of Karnataka's regulations for safety and security of students.
- Implementation of RTE act. Section 12(1) (c) from academic year 2018-19 to extent of 25% of total admissions in the entry level class.
