CONDITIONS:

1. This registration is subject to Rule 3 [5] [4].

8. Only trained and qualified teachers shall be appointed in accordance with the rules and regulations of the Department.
9. Medical examination of students should be regulated every year.
10. To deposit the security deposit in the account of District Deputy Directors and Governance Board of the institution to open the school.
11. Facilities such as school building, Infrastructure, library, playground shall be provided within a year; otherwise the registration will be cancelled.
12. The school shall notify the school and the student's enrolment information within three months of the school's registration or the beginning of the academic year, if the school does not open and the conditions are not met, the cancellation of the registration would be done.
13. Separate washrooms/toilets to be provided for boys and girls, clean drinking water should be provided.
14. Submission to the Deputy Director for first accreditation, the Consumer Education Act and the Government Order Date: 30.09.2010. Registration will be cancelled if it is not recognized within the stipulated period.
15. Safety of the school building from safety hazards such as a firestorm or an electrical accident should be accomplished and inspected, ensuring that the school bans the sale of tobacco products within 100 yards of the school premises, posting the same in the front of the school to be done.
16. The Department of Reserve reserves the right to cancel the registration of any misdemeanour information provided by the Child Administrative Council.

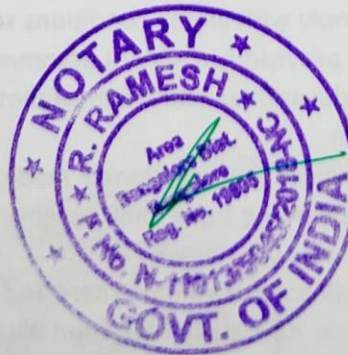
