Conditions:-

1. Maintaining student enrollment attendance in accordance with accredited classrooms and disciplines, with minimum attendance at the Education Act.
2. Providing school furniture, furniture, library book repository and other essential infrastructure.

3. Providing drinking water and separate toilet for boys and girls.
4. The fee shall be borne by the student at the rate fixed by the government and the bill shall be published on the instruction board.
5. Teaching as per the syllabus prescribed by the department and teaching in the approved medium.
6. Updating the list of Executive Committee members of the organization by the District Registrar within the year. Audit and submit the report to the concerned person within the year.
7. No additional sections shall be opened without the prior approval of the Department.
8. Accreditation is withdrawn if there are elements that contravene the provisions of the Karnataka Education Act 1983.
9. Registration and submitting school related documents and playground to the post of Secretary of the organization within 1 month.
10. It is conditional on employing trained teachers. The mandate of the service is mandatory, and the minimum wage payable by the bank is specified in the regulations.
11. Ensure safety of schoolchildren and warn them not to pose a danger if there is a hazardous electrical, fire, or deep well in the school premises. C. C. Camera installation and fire extinguisher are mandatory.
12. Build a school compound and manage the garden.
13. As of the date of notification of the Government, all the basic amenities and conditions such as land area, school building, and all other infrastructure and conditions shall be fulfilled within the stipulated time.
14. Government Safety Notification dated 08-03-2018, Child Safety Measures (Physical Safety That Includes Infrastructure, Health and Transportation, Personal and Sexual Safety, Social and Emotional Safety, Cyber safety, and Emergency Preparedness and Disaster Management).
15. Kannada must be taught as a first / second language according to the Kannada Language Learning Act-2015.
16. Don't miss the exposure details as soon as the online software is installed.
17. Failure to abide by the terms and conditions of reference 1 to 7.
18. If the documents and information provided in this regard are found to be false, this order is automatically dismissed.
