The Correspondent has submitted the application for Provisional Recognition for the class VIII (E.M) in the school for the years from 2022-23 to 2024-25 through the Deputy Educational Officer, Vijayawada in the reference 6<sup>th</sup> read above.

District Educational Officer, NTR District, Vijayawada has verified the application for Provisional Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994.

As per the instructions of the Director of School Education, AP, Amaravati vide ref. 4<sup>th</sup> cited under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada is Competent authority for Secondary Schools hereby grants Provisional Recognition for a period of 03 (THREE) years i.e., for the academic years from 2022-23 to 2024-25 for the class VIII (E.M) as recommended by the Deputy Educational Officer, Vijayawada and the District Educational Officer, NTR District, Vijayawada subject to fulfillment of the following conditions Sri Chaitanya EM High School, D.No.57-6-22, Old Post Office Road, Patamata, Vijayawada, NTR District under the management The Society of the Nexzen Educational Trust, Kasetti Heights, Ayyappa Society, Hyderabad, Rangareddy District. (Regd.No.234/IV/2009, Dt.26.12.2009) without Grant in aid now or in future and subject to fulfillment of the following conditions.

- 1. That the Educational Institutions shall serve the needs of the locality more particularly.
- 2. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management and age to the staff control of the st

5. That the results of institution shall be satisfactory every year.

6. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.

7. That the list of Governing Body shall be furnished to the District Educational Officer

every year.

8. That the pay structure / fee structure filed by the Governing Body shall be got approved by the District Educational Officer every year.

9. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.

10. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least months before.

11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.

12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least sVIII months prior to the date of expire of the present recognition.

13. That the society shall provide fire safety measures in the school as per the No Objection Certificate.

- 14. The management informed that no thatched roof accommodation is allowed to run the School.
- 15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
- 16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
- 17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments
- 18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children
- 19. The school shall have first aid kit and the teachers shall be trained in first aid
- 20. The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that the there is no deviation or violation of norms prescribed by the Government from time to time.
- 21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail
- 22. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
- 23. That the management has to maintain trained teachers at all time
- 24. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
- 25. That the Management of the school is informed that, these orders are issued subject to conditions that, to obtain and submit the occupancy Clearance of fire issued by the concerned department within the stipulated dates mentioned in the order and submit to this office through the inspecting officer concerned for the entire period of recognition without fail.

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed.
