District Kadapa is pleased to grant of Provisional Recognition for Classes I to V (EM) during the academic year 2015-2016 to 2024-2025 in respect of **Sri Chaitanya School Near RIMS BYPass Road,Near Swamy Nagar,Kadapa,Y.S.R.Dist.** without aid now (or) in future subject to the fulfillment of the following conditions.

- (1) That the society shall abide to the rules and regulations made in the Govt. orders 1st to 4th cited above.
- (2) That the Educational institution shall serve the need of the locality more particularly
- (3) That the institution shall adopt the curriculum and syllabus prescribed from time to time.
- (4) The School timings, vacations and mid term holidays shall be as prescribed in Govt. from time to time.
- (5) That the qualified staff within the age limits prescribed by the Government shall be appointed as per the staff pattern.
- (6) That the results of institution shall be satisfactory every year.
- (7) That the records/accounts shall be furnished to the District Educational Officer in the end of May.
- (8) That the list of governing body shall be furnished to the District Educational Officer every year.
- (9) That the pay structure, fee structure fixed in the Governing body shall be got approved by the District Educational Officer every year.
- (10) That all the conditions as prescribed in the G.Os and other order which are not specified in this order shall be completed unit.
- (11) That the School shall not be closed without giving notice both to the Parents/District Educational Officer and competent authority at least 6 months before.
- (12) That the School shall be closed on permitted to be closed only from the date on which summer vacation is declared.
- (13) That the Society shall submit proposals and for Renewal of Recognition sufficient in advance i.e., at least 6 months period to the date of expiry of that renewal.
- (14) Economic strength should be maintained in all classes if not the School has to be close down.
- (15) The management should be provided safety measures to the children from rains and natural calamities.
- (16) The management should be renewed the Fire certificate every year from the Fire dept and submit the same to the undersigned without fail.

Whereas, in the reference 11th read above permission has been granted for up gradation of UP School into High School by opening classes VI to X (EM) from the academic year 2017-2018 in respect of **Sri Chaitanya School, Near RIMS By Pass Road, Near Swamy Nagar, Kadapa, YSR District** run by **NEXGEN Educational Trust, Kasetii Heights, Ayyappa Society, Madhapur, Hyderabad.**

The **District Educational Officer, Kadapa** has verified the application for grant of Provisional Recognition with reference to the Inspection Report of the **Deputy Educational Officer, Kadapa** and also with reference to the conditions laid down in permission orders and submitted a report in her letter 13th read above and letter of the Correspondent, **Sri Chaitanya School, Near RIMS By Pass Road, Near Swamy Nagar, Kadapa, YSR District.**

After examining the references read above and the conditions prescribed in G.O.Ms.No.1 Education dated: 01.01.1994, G.O.Ms.No.41 Education dated: 11.05.2006, G.O.Ms.No.58 Education, dated: 13.07.2006, G.O.Ms.No.74 Education dated: 29.09.2008, G.O.Ms.No.123 Education dated: 27-09-2008, G.O.Rt.No.730 Education dated: 29-09-2008 and G.O.Ms.No.80 Education dated: 15.07.2009 the Regional Joint Director of School Education, Kadapa hereby accords Provisional Recognition to **Sri Chaitanya School, Near RIMS By Pass Road, Near Swamy Nagar, Kadapa, YSR District** for the classes VI to X (EM) for the academic years from 2017-2018 to 2026-2027 subject to the fulfillment of the following conditions.

1. That the society shall abide by the instructions/rules and regulations made by the Government or Authorized Officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
4. The School times, Vacations and mid-term holidays shall be as prescribed by government from time to time.
5. That the qualified staff within the age limits prescribed by the Government for Government Employee shall be appointed as per the staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records/accounts shall be furnished to the District Educational Officer every year 31st May at latest.

The Management is informed that as per G.O.Ms.No.1 Education dated: 01-01-1994, the fee collection from the students shall be allocated as to meet the following requirements:-

- a) 50% of the fees collected shall be earmarked towards payment of salaries to the staff.
 - b) 15% of fees collected shall be utilized for the maintenance of the institutions towards expenditure involving the building rent, electricity and water charges, stationery office payments to be made to menial and auditors, purchase of Library books, Lab Equipment and Chemicals and expenditure involving the upkeep of the institution etc.
 - c) 15% of fees collected shall be earmarked for the developmental activities of the institution.
 - d) 15% of the fees collected shall be earmarked as management's contribution towards staff benefits like gratuity, teachers provident fund, Group Insurance scheme etc.
 - e) 5% of the fees collected shall be earmarked as personal income to the Management.
8. Library should be enriched with at least 1000 books.
 9. E.W.F. Scheme should be implemented to all the staff members.
 10. That the list of Governing body shall be furnished to the DEO every year.
 11. That the pay structure/Fee structure fixed by the governing body shall be got approved by the DEO every year.
 12. That all the conditions prescribed in the G.O. and other orders which are not specified in these orders shall be complied with.
 13. That the School shall not be closed without giving notice both to the parents/ DEO and competent authority at least 6 months before.
 14. That the school shall be closed for permitted to be closed only from the date on which summer vacation is declared.
 15. That the society shall submit proposals for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the order. However by the end of April every year, the Educational agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time.
 16. The Management has to be obtain Fire Certificate (NOC) from the Fire Department and also to obtain and submit the Structural Soundness Certificate of the building from the E.E (PR) and E.E (R&B) as per the instructions issued by the Government within 02 months from the date of receipt of this order otherwise the Recognition will be cancelled automatically without given any further notice.
 17. Affidavit as per G.O.Ms.No. 41 Education, dated: 11.05.2006 should be submitted immediately.
 18. The Management has to submit the Administrative report along with audited Accounts statement every year without fail.

The receipt of the proceedings should be acknowledged.
