1．Mr．Ravi Periyannan $\mathrm{S} / \mathrm{o}$ ．Mr．Atunachalam Periyannan Aged about 53 years，Occupation：Business，Resident of Plot No．23，Chari Avenue，Palavakkam，Chennai－ 600041 ，hereinafter called＂Author of The Trust＂（which expression shall，unless excluded by repugnant to the context，be deemed to include his executors，administrators and representatives）of one part

2．Mr．Ram Swaroop，M S／o Mr．Vijaya Kumar．M Aged about 43 years， Occupation：Business，Resident of E No．G，Ground Floor，No．599， Anna Salai，Cathedral Garden Lane，Chennai－ 600006 ，Hereinafter referred to as＂TRUSTEE＂（which expression shall，unless excluded by or repugnant to the context，be deemed to include the trustee or trustees duly appointed for the time being of these presents and their successors in office）of the other part．



## WHEREAS

A. The Author of the Trust is desirous of establishing a Trust for public charitable purpose and being possessed of a sum of Rs. 10,000/(Rupees Ten Thousand Only) hereby settles the said amount on Trust. hereinalter appearing;
B. The Trustees have at the request of the Author of the Trust agreed to act as the First Trustees of the said Trust and these Presents;
C. The Author of the Trust desires to transfer the said amount to the Trustees on the execution of these presents to be held by the Trustees on trust and subject to the powers and provisions hereinafter contained.

## NOW THIS DEED WITNESSETH AND IT IS HEREBY DECLARED AS FOLLOWS:

1. Ip consideration of these premises and in order to effectuate the desire of the Author of the Trust, the Author of the Trust hercby transfer onto the Trustees the said sum of Rs, $10,000 /-$ (Rupees Ten Thousand only) to Have and to hold the same horeinafter refervedsas the "Trust Fund" unto the Trustees to use upon the Trust, with and subject to the powers, provisions, agreements and declarations hereinafter declared and

as well as all other sums，and any property，movables and immovable including lands that the Trust may receive from any person，organization， or other bodies or hold by way of purchase or by any other mode of transfer，grant or acquisition or by way of interest accrued on the Trust Fund and dividends，rents，or other income or accumulation howsoever received for the time being and from time－to－time hereafter．

2．The Trust hereby declared shall be known as＂SREE MURAGAN EDUCATIONAL TRUST＂（hereinafter also referred to as the said＇Trust＇） and shall not be for the benefit of any particular religion，sex，community or caste．The office of the Trust shall be at Plot No．23，Chari Avenue， Phlavakkam，Chennai－ 600041 ，Tamilnadu，India．Or at such other place as the Trustees may decide from time to time．自
3．The Trust and the Trust Fund shall be irrevocable for all times．

4．The objects of the Trust are enhancement of education imparting kthowledge to students of all age groups and shall include the following：
i．Ho sect up，establish in India，educational，institutions for imparting education to primary，secondary，primary \＆secondary education， Legree，professional and technical courses，distance education and adult education of the highest standards；


ii. to establish student friendly environments in the educational institutions of the Trust on the models of courseware/content of contemporary teaching institutions with supporting entities providing research/development and implementation of new improved teaching techniques so as to prove that in-depth learning means studying thoroughly and not rigorously:
iii. to impart such education to children/sudents in conformity with the norms and standards of the Board of Secondary Education, Board of Higher Secondary, Indian Council Secondary Education, Central Board Secondary Education, Board of Intermediate Education, and any other Competent Authority which is deemed fit for offering such course, by the educational institution;
10. to develop and prepare students by providing effective teaching and learning skills so as to composer leadership qualities and inculcate life skill welles in students including self discipline, hard work, honesty, integrity, truthfulness, efficient work culture, sportsmanship, courtesy, respect to elders and such other social and moral values;
v. to equip students with \& thorough understanding of the subject and the skills required to compete in life, and improve efficiency to their highest personal ability;
vi. to provide skills to manage in a competitive environment and a rapidly changing standards of competitive skills and provide the best of facilities to the student to develop such skill to sustain in this competitive environment;
viii to teach, impart and inculcate, develop and crahance skills in computers, sciences, languages, mathematics, engineering, medical, sports, tarts, social work and all other subjects of learning and imparting knowledge to students of all age groups;
viii. to conduct diverse'educational programs with the purpose of expanding the horizons, life choices and livelihood opportunities to all students including physically and mentally challenged students as also those from the deprived sections of society and rural communities;
ix. to conduct studies, seminars, workshops and study circles and to print, produce, publish, exhibit and distribute, films, jountals and periodicals, books, lectures and other reading and pictorial materials for the diffusion of useful knowledge in keeping with the aforestated objects including but not limited to providing scholarship, loans, grants and fellowships and further provide training or study opportunities for people in the field of development and ecological work;
x. to promote cultural activities and social work that will serve to enrich the lives of students and children and encourage national integration;
xi. to provide a space where persons who share the vision of the Trust can interact with each other and in the process help promote the aforesaid objectives;
xii. to utilize the Trust Fund for the benefit of the Trusts primary objectives and at no time and under no circumstances shall the Trust Fund be alienated;
xiii. to appoint, remove, charge, alter, delegate or outsource necessary support services or facilities as may be required, from time to time, for educational institutions of tine Trust;
xiv. io appoint advisors, professionals, eminent persons, educationalists and to [orm committees of the above for assisting the Trust in fulfilling its objects;

xy. to cnter inlo alliance with, cooperate or affiliate with such bodics organizations that have similar objectives or those that bolp in the advancement of ebjects of the Trust;
sv1 is do all other acts and things as are conolucive or helpfut th the advancoment. and fulfilinent of the principal objects above mentioned.
5. The Trustecs shall manage the Trust Fund and tany additional monies, donations, properties, given by the Author of the Trust or any other parties, as per the rules hereof and may pay, cxpend or utilize the Trust Fund and other amounles of the Trust towards the creation of assets and infrastructure for furthering the objects of the Trust as also towards proliminary expenditure, as the Trustees shall in theit discrelion decide, ber subject always to the other provisions bereof. It is expressly declared that no part of the income ot corpus of the Trust Fund shall be employed for suy object or purpose other than those of the Trust set out aforesaid. It is also expressly dectared that the Trusi Fund, hereby created is not for the purpose of discharging any obligations of the Author of the Trust, Trustees or any other person, nor for the purpose of any benefit to the Author of the Trust, Trustccs or any other person, save and except upon Trust as hereby dectared.
6. It shall be lawiul tor the Trustees, subject to the provisions hereos, to frame rules and regulations for administration of this Trust and for regulation and conduct of meetings of the Trustees. The Trustees from time to time alter, vary, modify such rules and regulations and substixale other rules and regulations in lieu thereof.
7. The Trustees shall be atidiberty ip retain the Trust Fund in the state of investment in which they roccive it or invest the same or any part thereof in or upon any investment for the lime being authorized by law for invesment of trusts and with further powers to invest the same subject to any enactment regalating investment of such funds it any ane or more of the following investments in or upon: i. fixed deposits witly any of the Scheduled Bark or Banks; ii. any security as specified in section 11(5) of the Income-Tax Act, 1961 or any statutory tnodification thereof;
e. the purchase of landson-imonable propertics in India;
b. construction or purchase, leasing, renting of buildings, tenements, properties; as misy be required for the fulfillment of the objects of the Trust;
c. And the Trustees shall be at liberty is vary and transpose the same into investments of the same or a like nature fom time to time as and when they shall in their absolute discretion think fit. and as may be permilled by the laws in force for the time being.
8. The Author of the Trust shall have final authority to alter, amend or modify the objects clause for the benefit of the Trust and the decision of the Author of the Trust on such matters shall be final.


9. The accounts of the Trust shall be opened and maintamed in the name of the Trust in any Nationalized. Bank/ Scheduled Bank as the Trustees shall decide from time to time. The accounts shall be operated by the persons as designated by the Trustees from time to time.
10. The Trustees shall examine the said accounts as and when required. All cheques and orders for the payment of money shall be jointly signed by Trustees or by such persons as aforesaid as are ermprovered to operate the accounts. Every sum of money received on account of the Trust shall be forthwith deposited and credited to the Trust account or accounts.
11. (i) The Trustees shall maintain true and accurate accounts of all money received and expended for the Trust and of the matters in respect of such receipts and expenditure took place. The account books shall be maintained on regular basis and completed at. The end of each Financial Yeas, ie. $31 \times$ March of each year, when consolidated statement of incorne and expenditure account and Balance Sheet for the year shall be prepared and thereafter be placed before the Trustees at a meeting for approval.
(ii) The accounts and consolidated statements shall be examined and passed by the Trustees at their first meetings of the following year or at such other meetings as may be called for the purpose. The accounts shall be duly audited (with all the
necessary vouchers / supporting papers) at least once a year by a Chattered Accountant appointed for the Trust.
(iii) The Trustees shall maintain a Register of the Trust Fund and its investment and the Trustees shall ensure that the Register is duly maintained and kept up-to-date, All books and records, title deeds and other documents of properties of the Trust shall remain in the custody of the Trustees at the office of the Trust and under the direct control of the Trustee.
(iv) The majority of Trustees shall have a final decision in matters relating to the Trust including utilization of properties of Trust and appointment, retirement or replacement of existing Trustees, as deemed necessary.
(v). The Trustees shall have the right to enter into contracts for carrying on The day to day workings of the Trash, through a Trustce/Trustecs, to be appointed at the first Mecting of the Trustees, who shall act for and on behalf of the Trustees in all matters as designated including in regard to employment of personnel as necessary, appointment of agents, professionals at such salary / remuneration as the Trustees may think proper; and the Trustees may at any time suspend or dismiss such persons and to do all other things and acts incidental to or connected with the furtherance of the objects of the Trust, as also delegate authority for the day-to-day administration of affairs of the Trust, as required from time to time.
12. The Trustees shall be responsible for the following:
(i) to implement the objects and rules of the Trust and implement its projects and the decisions of the Trustees in all matter

(ii) to prepare is maintain of Minutes and proceedings of all Trustee meetings:
(iii) to maintain accounts of the Trust Fund and ensure proper utilization is investment thereof as per this Deed and present the same at all Trustee meetings,
(iv) to maintain the bank account/s and monies of the Trust as per the terms and conditions stout herein;
(v) to ensure compliance of all legal of statutory requirements, including audit of the Trust from time-to-tinc;
(vi) to call for mooting of the Trustees from time-th-time;
(vii) to delegate all such matters including day to day actions required to be taken / done including correspondence, maintenance of docuraents and general secretarial work of the Trust including cxcoution of agreements, arrangements and contracts approved by the Trustees.
13. All charges and expenses of or incidental to the administration of the Trust shall be first defrayed by the Trustees out of the Trust Fund. Subject 16 the payment aforesaid, all the yearly income of the Trust shall be paid expended or tatilized for fulfilling the objects of the Trust and running the educational establishments of the Trust.
14. For achieving the objects of the Trust, the Trustees shall act as per law established and have following powers and authorities to:-

I make, alter and amend rules for the administration of the Trust and for carrying mut day to day requirements of the Trust;
ii. purchase, mortgage, acquire in exchange or dispose of any property, moveable and immeneable for the benefit of the Trust;
iii hire or take on lease, let or license, any immoveable or moveable property for the purposes of the Trust at such price or upon such rents and on such terms and conditions and for such period and with aud without option For renewal as the Trustees may think fig;
iQ. appoint and dismiss and reappoint teachers, professionals, managers, staff, ernployees, servants, clerks, care takers and others on such salary and on such terms as they think fit as required for educational institutions;
*. appoint and remove managers for assisting in day to day administrative affairs of the Trusts, as also delegate or assign any other activities as required from time to time;
$v 2$. delegate by Power of Attorney or otherwise to any Trustees or other persoris, any powers as may be required to be vested by the Trusties but the Trustees shall bo held liable or responsible for the acts or defaults of any such persons/ person bul only for their own respective acts end defaults;
vii. accept donations of money and for any property moveable or immoveable on such terms and conditions as the Trustees may think fit not being inconsistent with the objects of the Trust and the Trustees may accept a condition that such donation or any part thereof may be expended and applied in the name of the donor or any other name which the donor may indicate;
viii. appoint any person or persons to fill any vacancy or vacancies of the office of Trustee or Trustees, Provided always that the numborent



Trustees shall not exceed I1 (eleven) and tho be less than 2 (Two); The managing Trustee for the time being will be at liberty to appoint additional tuustec or tuasiees within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for tho time being consider proper and appointment of trustee or trustees later, shall be macle by the consent of all the trustees and tho Managing trustee for the administration of the Trust now appoints the following persons af the executive trustees of the Trust from this date onwards.
a) Mr, Revi Periyanman S/o. Mr. Arunachalarn Periyannan Aged about 53 years, Occupation: Busitiess, Resident of Plot, No.23, Chari Avenue, Pallawakkam, Chennai - 600041 .
b) Mr Ram Swaroop.M S/e MT, Vijaya Kumar. M Aged about 43 years, Coctppation; Business, Resident of E No.6, Ground Floor, No. 599, Anna Salmi, Cathedral Garden Lane, Chennai - 600006.
ix. decide all matters relating to the administration of Trust and Trust Fund and the decision of the Trustees on all such matters shall be finial;
$x$. make payments for the purposes of expenditure for the Trust, subject to the theme being duly accounted for and audited;
xi. grant lease in future any property of the Trust for such period and on such rented terms and conditions for the benefit of the Trust and income roccived there from shall be treated as income of the Trust:;
xii. reimburse themselves ar pay and discharge out of the Trust Fund or its: income all expenditure that may be incurred for fulfillment of the objects of the Trust, meluding holding of meetings, travel and other activities, the reimbursement shall not be operative in case of a Trustee held liable for es loss caused to the Trust by any act or inaction;
xiii. Hie and defend any legal proceedings taken in respect of Trust and ta activities and establishments, to lake all legal actions to protect the Trust and Trust Fund, enface right and title over the Trust through the Trusties and for the same to sign, declare and file proceedings, pleadings, affidavits and other documents, appoint, dismiss and reappoint advocate/ counsel, to pay lees and incise expenses for any proceedings, acts and things as may be trecesssary for the 'rust,
shiv. lake over, acquire, manage, oonise or aid any existing trust whose objects are either wholly or in part similar to the objects of the Trust, on such term and conditions as may be thought expedient,
xv. to establish, operate, maintain and from time to time alter, expand or reduce, takeover, acquire, control, merge, combine, control, os close educational institutions as also facilities of such educational institutions and other centers for coeducation:
xvi. borrow money, raise joan from persons, financial institutions, banks other authorized lending organtzaturs for the atmainment of objects of the Trust and for borrowing and raising loans, pledge or hypothecate the property of the Trust.,
*vii enter into or undertake such transactions, contracts or other activities as are conductive for attainment of the objectives of the Trust.


xviii. apply the whole or any part of the income of the Trush, or the Trust Fund or accurmblations thereto, to any one or more of the objects of the Trust, as the Trastees may, in their discretion, deed fit from time to time.
xix. appoint attorneys or agenta for the Trust and to delegate limited power to such attorncy as may be required from time to time and to remove such attorneys or agents and to appoint other or others in their place.
$x^{X}$ - give aid by way donetions, out of the nnome or the corpus of the Trust Fund or atherwise, to different efiucational institutions, societies, organzzations or trusts in India, which may have been established or which may hereafter be established for like educational purposes.
xxi. settle accounts, fite petitions, applications and legal proceedings for and in the name of the Trust, to compromise, compound, settle of refer to arbitration any such procseding of disputes in respect of claims, demand or things, as deemed expedient for the Trust and management. of its properties as also to safeguard against any loss oceasioned to the Trust.
xail. enter fono all types agreements/contracts with mividuai, trust, association of persons, bodics corporate, firms and others for the management of the Trust apd for the attainment of the object of the Trust.
xxiii, adjust, settle, compromise, compound and refor to arbitration all actions, suits, claima and demands and proceedings regarding the Trust Fund without being responsible for any loss occasioned thereby,
xxiv, appoint or make provisions the appaintment of any persons fall or any other trustees and committcos or administrators or otherwise) for the purpose of the administration of the Trust in such a mamer and subject to such rules and regulations as the Trustees may prescribe and also to appoint or provide for the appointment separate Trustees io hold any fund, or investment subject to the provisions of this deed in such a manner thd slabject (6) such rules and regulations as the Trustees nay deem fit and proper, from time to time,
xov, wake, vary, alter or modify schemes, eules and regulations for carrying out the objects of the Trust and for management of affairs thereof and /or running any cducational institutions in furtherance of the objects of the Trust,
xxve. set apart and/or allocate the whole or part of income or the sorpus Trust Fund or part thereof for any, of ihe objccess of the Trust,
xxyii apply to Government, public bodics, urban, local, municipal, district and other bodies, corporations, compames or persons for and to accept grant of money, aid, donations, gifts, subscriptions and other assistance with a vicw to promote the objects of Trust and to discass and negotiate with Government Departments, public and other bodies corporations, companies or person, schemes and other works and matters within objects of Trust and to conform to any conditions upon which such grants and other payments may be raade,
xxyiii. purchase or otherwise acguire and undertake all or any part of the property, essets, liabilities and engage any onc or more of the trusts, societies, inslitutions or associations those which are taken over by this Trust,
xxix purchase or otherwise acquire and undertalse properly, assets, liabilities and other moveable or immovable properties in the name of Trust as decided by the Trustees as per their discretion,

xxx to establish, operate, maintain and from time to time alter, expand of reducc, tancover, acquire, vontrol, merge, combinc, contcol, or close educational instimutions as also facilities of such educetional institutions and other centers for education.
15. The Trust may form commitees comprising of experts, professionals, eminent persons to assist the Irustees in fulilling the objects of the Trust. Such committees shall evaluato, catimate, and recommend, to the Trust for fulfilling the objects of the Trust.
16. The Trust shall give receipl through the Trustecs for any money, security or properly transforred to the Trust which shall effectaally discharge the person or persons so paying transferring the same.
17. If the Trustees hereby constituted or any of them of the Trustec, of Trustees appomed hereinaftcr provided shall die or desire to be discharged or refuse or become incapable to act or is adjudicated insolvent or convicted of a criminal offence involving moral turpitude and punished with imprisonment excecding six months or be abseat from India for a period of 12 months or more sithout obtaining the leave of the other Trustces in writing or absconding for at period of six months, then the surviving or the continuing Trustees for the time being may, subject to the other provisions hereof, appoint another person or persons as Trustee in the place of the Trustec. Such appointment of new trustoc shall be made by consensus of majority of Trustces. In the event of Trustee or Trustees acting contrary to the presents of the Trash, the remaining Trustecs shall have the right to remove such Trustee or Trustees alter due coasideration and consensus.
18. All Trustees appointod aro on the express condition that he/she shall not charge any fee or remuneration for any work to be done by him/her in connection with the Trust. A Trustco shall be entitled to claim expenses of travel and other out-of pocket expenses insurred by him/her for attending mocting of the Trustees or any sub-commitlee thereof.
19. Any Trustees being an advocater architect, accountant or other professional person shall be entited to be paid usuat professional charges for professional services rendered to the 'rust.
20. The Trustecs shall be respectively liable for their actions in conformity and shall be answerable athd accountable only for their own gels, neglects and wilful defaults and not for those of each other nor for those of any bankers, brokers or other person in whose hands amy rust moncys or securities may be placed nor for deficiency of funds or security nor otherwise for any voluntary losses unless the seme shall happen due to or through their or his own willful defaults.
21. (f) Notice along with agenda for a Trustees Meeting shall be sent to all Trustecs at their respective address by the Trustees, at least ? days prior to a meeting.


(ii) Meeting of the Trustees shall be held as and when required at such) place as may be decided by the H rustces.
22. Any agreement or instrument may be signed, executed and fegintexed by any Trustee duly authorized by ar resolution passed by the Trustees in regard thereto and such agreement or instrument, so executed by a Trustee shall bo decried to be signed, executed and registered by or on behalf of all Trustees for the time being.
23. The operation of the Trust shall be in the whole of India.
24. The Trustee may merge the Trust into a Society, Section 25 company, firm and/ or other educational trust which has similar objects as this Trust. Upon the happening of any of the events contemplated in clause 3 hereinabove, the Trustees shall be empowered to wind up, revoke or close the Trust and transfer the Trust Fund, properties of the Trust as also any educational institutions established and maintained under the Trust te a Society, Section 25 company, firm and/or other educational trust which has similar objects' as this Trust or as deemed it and proper by the Trustees.
25. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income on capital any expenses or out goings ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the trustees to spend the income of corpus of the Trust for any purpose not authorized by these presents.
26. If the Trustees are desirous of altering, changing, modifying, deleting or adding any clause or clauses of their Trust deed they shall do so as per the provisions of the Indian Trust Act, with the prior approval of the commissioner of Income Tax having jurisdiction over the Trust and by following necessary procedures and prescribed by the Indian Trust Aet.
27. To transfer or hand over the Trust to any other Trust, society, institution or organization in case of winding up of the Trust the Trustee shall transfer ali the assets of the Trust training after clearing off all ifs debts. The trustee shall do so with the prior approval of the commissioner of Income Tax having jurisdiction over the Trust and on such Trust and on such terms and conditions the commissioner of Income Tax shall impose and the transfer of the assets shoal be done as mentioned above, only to the trusts, societies, institutions or organizations, having similar objects as that of this trust and which are having registration under Section 12A 80. under Section BOG of the Income Tax hat and the properties handed over as stated above to at her Imposts, societios, institutions or organizations shall bean the name of this Trust and shall be maintained as s separate entity by the absorbing Trust,

28. It is expressly declared that no part of the Trust property or its income of any accretion there to shall be distributed among the members of the Trust either directly or indirectly by way of profit or dividend or otherwise and further the benefits of the Trust are open to all irrespective of caste, creed, community, scx, religion etc.

At present there is no movable or immovable property in the name of the trust. This Trust is running at Rental Building.
